

Melbourne FC - Armchair Selector Terms and Conditions

By entering the **Armchair Selector** competition ("promotion"), you agree to the following conditions:

1. Information on how to enter forms part of the terms and conditions of entry. Entry into the promotion is deemed acceptance of these terms and conditions.
2. The Promoter is Melbourne Football Club (ABN 27005686902) ("Melbourne Football Club" or the "Promoter").

Eligibility

3. Entry is open to all Australian residents ("Eligible Entrants") excluding directors, management, employees (and their immediate families) of the Promoter and its related bodies corporate and registered travel companions of employees of the Promoter and its related bodies corporate.

Competition entry

4. To enter the Promotion, Eligible Entrants must submit a full list of 22 players ("predicted team") in the online entry form and provide correct contact details.
5. The promotion will run on a weekly basis during the 2019 AFL Premiership season, opening each Monday at 3.00pm and closing at 6.00pm on Thursdays (AEDT/AEST) prior to Melbourne's final team or squad submission ("Promotion Period"). During Round 4 and 6 the promotion period will run on an altered entry timeline as below:

Round 4 – Competition runs Monday 8 April 3.00pm until Wednesday 10 April 6.00pm

Round 6 – Competition runs Monday 22 April 3.00pm until Tuesday 23 April 6.00pm

6. Privacy Notice: The Promoter will collect your personal information so you can enter, and they can administer this promotion. Your personal information is required for The Promoter to contact you in the event that your entry is deemed the winning entry. All personal and sensitive information you provide will be used by the Club including for promotional and marketing purposes in accordance with our Privacy Policy, available at www.melbournefc.com.au/privacy and may be disclosed by the Club in accordance with the Club's Privacy Policy. Judging criteria

8. The promotion is a skill-based competition, with entrants required to correctly predict Melbourne's team of 22 players who take the field in a 2019 Premiership Season fixture ("final team").
 - a. If a player comes into Melbourne's team as a late change on match day, they will be considered a part of the final team. Conversely, the player withdrawn from Melbourne's line-up will not be considered a part of the final team.
 - b. Entrants are only required to submit the correct 22, which can be in any order with ground positions not considered a part of judging criteria.
 - c. Players named as emergencies, who do not play will not be considered a part of the final team.

9. The entrant who correctly predicts Melbourne's final team will be deemed the winner, with the prize to be drawn the Monday following each Melbourne fixture at 11:00am at the MCG, Brunton Ave, East Melbourne, 3002.
10. Should one or more entrants correctly select the final team, the entrant who submitted an online entry form the earliest will be deemed the winner.
11. If no entrant correctly predicts the final team, no prize will be awarded for that round.
12. The winner will be contacted in writing via the contact details provided in the online entry form. The Promoter holds no responsibility for incorrect or insufficient details provided by the entrant. Should an entrant's details change, it is the responsibility of the entrant to provide these details to the Promoter.
